



- Advance Notice is Prohibited
- An Investigation Team Will Show Up
 - OSHA Inspectors
 - Possible Wage and Hour Inspectors

OSHA

> 10 employees or temporary labor camp

Wage and Hour

- > 500 man days)non-family) all quarters prior year (usually 5 – 6 employees)
- Subpoena power under 29 U.S.C. § 209, 211
- Housing inspection if counted toward minimum wage

What is the Department of Labor looking for when they investigate?

Section 5(a)1 – general duty clause

1928 – standards for agriculture


1910.142 – temporary labor camps

1910.111(a) and (c) - anhydrous ammonia

1910.266 – logging operations

1910.145 – slow moving vehicles

1910.1200 – hazard communication



What are the penalties and consequences of the investigation?

OSHA

- Up to \$7,000 Serious Citation
- Up to \$70,000 Willful Citation
- Minimum penalty \$250 per violation

Wage and Hour

- Back pay at minimum wage x \$7.25/ hour
- If housing does not meet code, it cannot be counted

How should the Dairy Business operator prepare for the investigation?

Reduce size below CAFO level

OR

- If > 10 employees and/or on-site housing
 - Engage outside consultants
 - Review housing code compliance
 - Field equipment safety
 - Hazard communication
 - Skid-steer training
 - General safety
- If employees enter grain storage Utilize resources for assistance

How should the Dairy Business operator behave during the investigation?

Know your rights

- Are you big enough to be covered?
- Were you selected randomly or due to an accident or complaint?
- You always have a right to a federal warrant (OSHA)
- You do not have to provide demonstrations.
- You have the right to be present during inspection.
- Private interviews only allowed of non-management and not while demonstrating work tasks (see above).
- Be polite, professional and prepared.

Machine Guarding: 1928.57

- This section applies to all farm field equipment and farmstead equipment
 - Power Take Off
 - Power transmission devices belts, chains, shafts
 - All moving equipment fans, gates
- Operating instructions. At the time of initial assignment and at least annually thereafter, the employer shall instruct every employee in the safe operation and servicing of all covered equipment with which he is or will be involved
- Permit no riders on farm field equipment
- ROPS and seatbelts



1910.147: Control of Hazardous Energy Lockout-Tagout (5a1)

- Written LOTO Procedures
 - Some equipment is exempt
- Individual Employee Protection (Locks)
- Shift Change/Authorized Lock Removal
- Annual Audit





Personal Protective Equipment (PPE): 5a1

- 1910.132 Hazard Assessment
 - Required PPE
 - Written Certification
 - Training



- Identify Permit Required C.S. in workplace
- Prohibit Unauthorized Entry
- Written Program
- Entry Procedures
 - Entry Permit
- Annual Audit

Access, Entry, Gases, Moving Parts, Electrical, Fires, etc.






Figure 2. A typical top-unloading or conventional silo


Manure Pits-Lagoons (5a1)

- Established Standard:
 - American Society of Agricultural and Biological Engineers (ASABE)
 - ASEA EP470 Jan 1992 (R2005)
 - Manure Storage Safety
 - Waste Storage Facility
 - National Resources Conservation Service
 - Code 313
- Hazard: Hazardous Atmosphere, Falls

- Wall Collapse

- Spliced cords


