Each year, Farm Credit East and CoBank award grants ranging from \$500 to \$10,000 to help organizations promote awareness and strengthen agriculture, commercial fishing and forest products industries in the six New England states, New York and New Jersey. Beginning Farmers

Agriculture Innovation Center Program

The Agriculture Innovation Center (AIC) Program provides grant funding to organizations that support agricultural producers in developing, expanding, and marketing value-added agricultural products. Funds may be used to provide business planning, market development, financial and technical advisory services, product and process development, value chain coordination, and limited direct assistance grants to agricultural producers. The program is designed to strengthen agricultural businesses, improve market access, and support innovation across the agricultural sector.

Eligible Recipients

- *Commercial Organizations*
- *Indian Tribes*
- *Institutions of Higher Education*
- *Local Governments*
- *Nonprofit Organizations*
- *State Governments*

Funding Amount: Up to \$1,000,000

Farmer Veteran Fellowship Fund

Sponsor/Agency: Farmer Veteran Coalition

The Farmer Veteran Fellowship Fund provides direct assistance to veterans in their beginning years of farming or ranching. The fund supports purchases from third-party vendors for resources to assist in the startup of a farm business.

Eligible Recipients: Farmer Veteran Coalition Members with Agricultural Businesses

Funding Amount: \$1,000-\$5,000

Sponsor/Agency: *The Carrot Project*

For over 15 years, The Carrot Project has worked with farm and food businesses in New England and the Hudson Valley, supporting their successes by helping them build the financial management skills needed to help their businesses thrive. The Carrot Project offers free or low-cost business technical assistance and consulting, as well as a beginning farmer loan program.

Eligible Recipients:

- *Farm, Forestry and Fishery Businesses in New England.*
- *Processing, Distribution, and Storage enterprises that use any type of local agricultural product*

Funding Amount: \$5,000-\$250,000

Conservation, Environment and Forestry

Agricultural Management Assistance

Sponsor/Agency: USDA National Resources Conservation Service

The Agricultural Management Assistance (AMA) program provides financial and technical assistance to agricultural producers to voluntarily address issues such as water management, water quality and erosion control by incorporating conservation into their farming operations. Producers may construct or improve water management structures or irrigation structures; plant trees for windbreaks or to improve water quality; and mitigate risk through production diversification or resource conservation practices, including soil erosion control, integrated pest management or transition to organic farming.

Eligible Recipients: Livestock or Agricultural Producers

Funding Amount: up to \$50,000

Brighter Future Fund

Sponsor/Agency: American Farmland Trust

The American Farmland Trust (AFT) Brighter Future Fund grants help drive new solutions for resolving key challenges facing our society by increasing the resilience of farms to climate change and reducing greenhouse gas emissions, strengthening local food systems, creating greater equity in opportunities for underserved farmers, ensuring the availability of sufficient clean water and habitat for threatened wildlife, and improving farm viability and community vitality. Previous Brighter Future Fund grants included the National Farm Viability Grant, Regenerate VA, and New England Regenerative Livestock Farming Grants. Eligible Recipients:

- *Applicants must be based in the U.S.*
- *Must be a for-profit business with proof of income*
- *Must have proof of financial hardship as a direct result of disruptive events in recent months*

Funding Amount: Subject to the details of the grant

Conservation Innovation Grants (CIG)

Sponsor/Agency: *USDA Natural Resources Conservation Service (NRCS)*

CIG provides funding for innovative conservation projects that improve soil health, water quality, air quality, and wildlife habitat on private lands.

Eligible Recipients:

- *State and local governments*
- *Tribal governments*
- *Nonprofit organizations*
- *Colleges and universities*
- *Private organizations and individuals*

Funding Amount: *USDA is providing \$65 million for national CIG projects this year.*

Conservation Reserve Enhancement Program

Sponsor/Agency: *USDA Farm Service Agency*

The Conservation Reserve Enhancement Program (CREP) targets high-priority conservation concerns identified by a state, providing federal funds which are supplemented with non-federal funds to address those concerns. In exchange for removing environmentally sensitive land from production and establishing permanent resource conserving plant species, farmers are paid an annual rental rate along with other federal and state incentives as applicable per each CREP agreement. Participation is voluntary, and the contract period is typically 10-15 years.

Eligible Recipients:

- *States*
- *Tribal Governments*
- *Non-profit and Private Entities*

Funding Amount: *up to \$50,000*

Conservation Reserve Program

Sponsor/Agency: *USDA Farm Service Agency*

The Conservation Reserve Program (CRP) is a land conservation program administered by the Farm Service Agency (FSA). In exchange for a yearly rental payment, farmers enrolled in the program agree to remove environmentally sensitive land from agricultural production and plant species that will improve environmental health and quality. Contracts for land enrolled in CRP are 10-15 years in length.

Eligible Recipients: *Producers who have owned and operated the land 12 months prior signing up (some exceptions may apply)*

Funding Amount: *Participants receive annual rental payments based on soil productivity and the average cash rental rates in the county. Cost-share assistance is also available for up to 50% of the cost of establishing approved conservation practices.*

Conservation Stewardship Program

Sponsor/Agency: USDA National Resources Conservation Service

The Conservation Stewardship Program (CSP) helps agricultural producers maintain and improve their existing conservation systems and adopt additional conservation activities to address priority concerns.

Eligible Recipients: Agricultural and Forest Producers interested in conservation and environmental stewardship

Funding Amount: Most participants will be eligible for a \$4,000 minimum payment during any year that their total annual contract payment falls below the minimum payment amount.

Emergency Conservation Program (ECP)

Sponsor/Agency: Farm Service Agency

This program helps farmers and ranchers to repair damage caused by natural disasters and to help set up water conservation methods during drought.

Eligible Recipients: Land damaged by natural disasters inspected by the FSA county committee and meet eligible criteria.

Funding Amount: \$50,000-\$100,000+

Emergency Forest Restoration Program

Sponsor/Agency: Farm Service Agency

This program helps to rebuild non-industrial forest owners and restore forest health through financial assistance.

Eligible Recipients: Land damaged by natural disasters inspected by the FSA county committee and harms the natural resources on the land and affects future land use.

Funding Amount: \$50,000-\$500,000

Emergency Watershed Protection Program

Sponsor/Agency: USDA National Resources Conservation Service

The Emergency Watershed Protection Program (EWP) was established by Congress to respond to emergencies created by natural disasters. The EWP is designed to help people and conserve natural resources by relieving imminent hazards to life and property caused by floods, fires, drought, windstorms and other natural occurrences.

Eligible Recipients: Public and Private Landowners (must be represented by a project sponsor)

Funding Amount: up to 75% of eligible construction costs

Environmental Quality Incentives Program

Sponsor/Agency: USDA National Resources Conservation Service

The Environmental Quality Incentives Program (EQIP) is a voluntary program that provides financial and technical assistance to agricultural producers to plan and implement conservation practices that improve soil, water, plant, animal, air and related natural resources on agricultural land and non-industrial private forestland.

Eligible Recipients: Farmers, Ranchers, and Forest Landowners who own or rent agricultural land

Funding Amount: Subject to the details of the grant

High Tunnel System Initiative

Sponsor/Agency: USDA National Resources Conservation Service

A part of the EQIP program, the NRCS High Tunnel System Initiative is a conservation program that helps individuals and legal entities engaged in agricultural production install high tunnel (“hoop house”) greenhouses to extend their growing season.

Eligible Recipients:

- *Agricultural Producers*
- *Owners of Non-Industrial Private Forestland*
- *Indian Tribes*
- *Individuals with an interest in Agricultural or Forestry operations*
- *Water Management Entities*

Funding Amount: Cost share, amount subject to the details of the application

Landscape Scale Restoration Grants

Sponsor/Agency: USDA Forest Service

The purpose of the Landscape Scale Restoration (LSR) competitive grant program is to encourage collaborative, science-based restoration of priority forest landscapes, leverage public and private resources, and support priorities identified in State Forest Action Plans. The LSR request for applications comes out once per year.

Eligible Recipients:

- *State Forestry Agencies or other appropriate State Agencies*
- *Units of Local Governments*
- *Indian Tribes*
- *Non-Profit Organizations*

Funding Amount: up to 50% of project costs

New England Grassroots Grants

Sponsor/Agency: New England Grassroots Environment Fund

The Grassroots Fund interprets the word ‘environment’ broadly and will provide funding for a wide range of community-based environmental projects, including those involving agriculture and food systems. **Grow grants** are geared to established groups who are ready to expand the scope of their work. **Seed grants** are geared to groups launching new projects and/or evolving the scale of an existing project. Grants are intended to support community groups that are not being reached by traditional funders.

Eligible Recipients: Groups doing work in CT, ME, MA, NH, RI, and VT

Funding Amount: \$1,000 - \$4,000 for Grow Grants, \$500 - \$1,000 for Seed Grants

The Fruit Guys Community Fund

Sponsor/Agency: The Fruit Guys Community Fund

This fund was created to provide grants to small farms and agricultural nonprofits that support sustainable agriculture projects with large positive impacts on the environment, local food webs, and farm diversity.

Eligible Recipients: Small U.S. farms of 250 acres or less and qualified 501(c)(3) agricultural nonprofits. Applicants must own or operate the farm or have long-term legal access to the land.

For-profit farms must have operated for at least 2 years, and nonprofits for at least 3 years.

Funding Amount: Up to \$5,000

Dairy

Dairy Co-Packing Grant

Sponsor/Agency: Northeast Dairy Business Innovation Center

The Dairy Co-Packing Grant will provide funds for existing Northeast dairy processors to initiate new co-packing arrangements or to expand existing co-packing capabilities. Along with funding grantees will also gain technical assistance or training as a subset of their funds in their projects. Funds will purchase specialized dairy processing equipment, increase food safety, and product development.

Eligible Recipients: Applicants must be licensed dairy processors that currently meet the following in the Northeast:

- *Transforms raw milk or dairy component into an edible product meant for human consumption*
- *It is licensed in a way that their dairy products can be sold across state lines*
- *Is headquarters or based in the Northeast*
- *Sources or produces milk or dairy components from within the Northeast*
- *Manufactures products within the Northeast*

Funding Amount: \$15,000-\$150,000 with 25% cash match contribution

Dairy Farm Innovation & Modernization Grant

Sponsor/Agency: Northeast Dairy Business Innovation Center

The Dairy Farm Innovation & Modernization Grant program will provide grants for dairy farmers to access resources and technical assistance to support the implementation of community- and climate-forward production strategies.

Eligible Recipients:

- *Licensed Dairy Farmers/Producers based in the Northeast*
- *Producer Associations that represent, support, or promote dairy products originating from the Northeast*
- *Technical Service Providers*

Funding Amount: \$15,000-\$100,000

Dairy Food Safety and Certification Grant

Sponsor/Agency: *Northeast Dairy Business Innovation Center*

The Dairy Food Safety & Certification Grant program will provide grants for dairy farmers, processors, and/or producer associations to take actionable steps to improve the safety of dairy products. Activities covered under this grant include accessing technical assistance, audits, food safety plan development, training, testing fees, and certain infrastructure upgrades.

Eligible Recipients:

- *Dairy Farmers/Producers of milk that is headquartered or based in the Northeast or sources or produces milk in the Northeast*
- *Dairy Processors that are headquartered in the Northeast that transform raw milk into an edible product with milk sourced from the Northeast region*
- *Dairy Processor Association/Dairy Councils which represents and promotes dairy products/dairy businesses of the Northeast*

Funding Amount: *\$10,000-\$75,000*

Dairy Indemnity Payment Program (DIPP)

Sponsor/Agency: *USDA Farm Service Agency*

The (DIPP) program was created to help support dairy farmers when they get batches of contaminated milk. The program provides payments to farmers who cannot sell their milk on the commercial market due to contamination from residues, chemicals, toxic substances, or nuclear radiation. This helps farmers to recover from the loss in products and continue their operations.

Eligible Recipients: *Dairy producers who have experienced milk contamination or have had to remove dairy cows from production due to residues, chemicals, toxic substances, or nuclear radiation*

Funding Amount: *Dependent on quantity of dairy products and cows that were contaminated*

Dairy Margin Coverage Program (DMC)

Sponsor/Agency: *USDA Farm Service Agency*

The (DMC) program was created to protect dairy farmers from decreases in milk prices and increases in feed prices. It will protect farmers when the margin between the all-milk price and average feed cost falls below the coverage level chosen by the producer. There are different levels of coverage, but by enrolling in this program you can hedge away some of the risk that is involved with price fluctuations of commodities.

Eligible Recipients: *Dairy farmers in the United States that produce and commercially market milk from cows*

Funding Amount: *Dependent on the coverage you buy and prices of milk and feed*

Dairy Marketing & Branding Services

Sponsor/Agency: The Northeast Dairy Business Innovation Center (NE-DBIC)

The Dairy Marketing and Branding Services Grant program will provide grants for established value-added dairy processors and producer associations to access professional marketing and branding services to elevate value-added dairy businesses.

Eligible Recipients:

- *Dairy Producers that transform raw milk sourced from the Northeast region into an edible product*
- *Dairy producer associations/dairy councils which represent and promote dairy products and dairy businesses of the Northeast*

Funding Amount: \$10,000-\$50,000

Dairy Processing Research & Development Innovation Grant

Sponsor/Agency: The Northeast Dairy Business Innovation Center (NE-DBIC)

The Dairy Processing Research & Development Innovation Grant program. This grant will provide funds for dairy processors, dairy producer associations, and educational institutions to conduct research and development projects that support innovation for Northeast dairy processors across a variety of scales.

Eligible Recipients:

- *Licensed Dairy Producers and Producer Associations based in the Northeast.*
- *Educational or Research institutions can also apply but are required to partner with a minimum of two Northeast-based dairy producers.*

Funding Amount: \$75,000-\$250,000

Dairy Processor Modernization Grant

Sponsor/Agency: Northeast Dairy Business Innovation Center

Funds will support dairy processors and dairy brands in modernizing their production to allow for increased processing of regional dairy, long-term business viability, and ability to meet consumer demands. Projects funded through this grant will focus primarily on acquiring specialized equipment for dairy processing that offers benefits such as increased capacity, higher efficiency, reduced energy usage, increased quality, or ability to produce new or higher-value products.

Eligible Recipients: Dairy processors and dairy brands that market Northeast dairy products produced by a licensed dairy processor under a co-packing or other arrangement.

Funding Amount: \$15,000–\$250,000 / Dependent on size of operation and need

Existing Dairy Processor Expansion Grant

Sponsor/Agency: Northeast Dairy Business Innovation Center

The Existing Dairy Processor Expansion Grant addresses the significant need for investment in processing infrastructure in the Northeast. This grant will only fund existing dairy processing facilities located in the Northeast region with a focus on expanding utilization of regionally sourced milk, dairy components, and/or dairy mix, and diversifying the supply chain.

Eligible Recipients: Licensed Dairy Processors located in the Northeast who process regionally sourced milk in the Northeast and are compliant with state and federal standards

Funding Amount: \$75,000-\$350,000 (Dependent on Funding Tier)

Organic Dairy Product Promotion Grant

Sponsor/Agency: Northeast Dairy Business Innovation Center

The Organic Dairy Product Promotion Grant program was started to drive an increase in regionally produced USDA certified organic dairy products in youth-serving institutions. This program is made possible through funding from the USDA's Commodity Credit Corporation (CCC), and as such, funds can only be used to purchase organic dairy products for use in youth-focused institutional food service programs (ages 5-25).

Eligible Recipients:

- *Licensed dairy processors*
- *Dairy distributor*
- *Youth Institution*

Funding Available: \$50,000-\$500,000

Rural Energy for America Program (REAP)

Sponsor/Agency: USDA Rural Development

The Rural Energy for America Program (REAP) provides grants and loans to farmers and businesses for energy efficiency improvements and purchase of wind, solar or other renewable energy systems, and provides grants to help farmers with energy audits and renewable energy development.

Eligible Recipients: Agricultural Producers and Small Businesses

Funding Amount: up to 75% of total eligible project costs

Rural Energy for America Program Energy Audit & Renewable Energy Development Assistance Grants

Sponsor/Agency: USDA Rural Development

This program assists rural small businesses and agricultural producers by conducting and promoting energy audits and providing Renewable Energy Development Assistance (REDA).

Eligible Recipients:

- *State and Local Governments*
- *Federally Recognized Tribes*
- *Land-Grant Universities or other Institutions of Higher Education*
- *Rural Electric Cooperatives*
- *Public Power Entities*
- *Instrumentalities of State, Tribal, or Local Government*
- *Resource Conservation & Development Councils*

Funding Amount: up to \$100,000

Commercial Fishing Occupational Safety Training Grants

Sponsor/Agency: Centers for Disease Control-ERA

The goal of the training grant program is to enhance the quality and availability of safety training for United States commercial fisherman. Availability includes the frequency, geographic considerations, channels or partners of dissemination, culturally and/or educationally appropriate training material, and other characteristics of a successful training program.

Eligible Recipients:

- *County Governments*
- *Native American Tribal Governments*
- *Private Institutions of Higher Education*
- *City or Township Governments*
- *Public and State Controlled Institutions of Higher Education*
- *For-Profit Organizations*
- *Small Businesses, State Governments*

Funding Amount: \$150,000-\$975,000

NOAA Fisheries Grant Opportunities

Sponsor/Agency: National Oceanic and Atmospheric Administration (NOAA)

Milk Producer (Dairy Sustainability) Grant

Public Act No. 09-229 provides grants to Connecticut producers of cow's milk for pasteurization. Milk Producer Grants are quarterly grant payments for Connecticut dairy producers. The payments are determined by a formula based on regional prices and cost of production.

Funding Amount: Grant payments are calculated based on the gap between a state-determined sustainable milk production cost and the federal milk price, multiplied by the producer's monthly milk production, with payments adjusted if total requests exceed available funding.

Property Tax Exemption for Farm Buildings and Farm Machinery

Sponsor/Agency: CT Department of Agriculture

Up to \$100,000 in assessed value for farm equipment and machinery. An additional \$100,000 for machinery if the municipality votes to approve such an exemption. An exemption for each farm building used exclusively in farming to an assessed value of up to \$100,000, also if the municipality votes to approve. In order to receive any of the above exemptions, you must derive at least \$15,000 in gross sales or demonstrate \$15,000 in expenses on the farm. You also must declare to Town by November 1 (within 30 days after the assessment date).

Funding Amount: up to \$100,000 in tax exemptions

Woods WISE Incentives to Stewardship Enhancement

Sponsor/Agency: Maine Department of Agriculture, Conservation & Forestry

Taking care of woodlands is extremely important to Maine's economy and well-being. A key element of woodland stewardship is working with a professional forester to develop a management plan. The Woods WISE Incentives program currently offers cost-share assistance for forest management planning known as a Woodland Resource Action Plan (WRAP). A WRAP will provide a good description of the current and potential values of your woodland, and a blueprint of activities to reach your objectives to maintain and improve your woods.

Eligible Recipients: Maine landowners who own 10-1,000 forested acres statewide. Ownerships of up to 5,000 forested acres may also be eligible under certain circumstances. Landowners may be individuals, families, organizations such as land trusts, or businesses.

Funding Amount: Landowners may receive reimbursement for eligible planning, forestry, and implementation expenses, with payments based on established maximum reimbursement rates.

Agricultural Preservation Restriction Program (APR)

Program designed to protect agricultural land, particularly farmland soils, from being developed or used for non-agriculture purposes. On a voluntary basis, the program will buy the development rights on agricultural land in exchange for a permanent deed restriction, securing its future use as agricultural land.

Eligible Recipients: Farms at least 5 acres in size that have been actively devoted to agriculture for the two preceding tax years. Farms must produce at least \$500 in gross sales per year for the first five acres plus \$5 for each additional acre or \$0.50 per each additional acre of woodland and/or wetland.

APR Improvement Program (AIP)

Cranberry Bog Renovation Grant Program

Dairy Farmer Tax Credit Program

The Dairy Farmer Tax Credit Program enables a dairy farmer who holds a Certificate of Registration to receive a refundable income tax credit based on the amount of milk produced and sold. The credit shall be based on the United States Federal Milk Marketing Order for the applicable market such that if the United States Federal Milk Marketing Order price drops below a trigger price anytime during the taxable year, such taxpayer may receive the tax credit.

Funding Amount: The dairy farmer credit is a refundable tax credit. The total amount of credits granted through the program cannot exceed \$8,000,000 in any year.

Milk Security Program

The main objective of the security program is to protect producers against loss of income in the event a milk dealer defaults in paying for milk received. Pursuant to Section 258-b of Agriculture and Markets Law, licensed dealers who purchase milk directly from producers or cooperatives are required to secure their purchases by either participating in the state's Milk Producers Security Fund (MPSF) or by filing full alternate security in the form of a bond or letter of credit. Milk sales between cooperatives are exempt from this security provision.

Funding Amount: Dealers participating in the MPSF must pay a \$0.012 per hundredweight assessment on milk purchases and, unless exempt, provide financial security (surety bond or letter of credit) covering at least 12 days of purchases, with exemptions generally available for dealers whose 40-day purchases are under \$250,000.

Eligible Recipients: *Pennsylvania state agencies and local municipal entities that own eligible dirt, gravel, or low-volume roads. Roads must be open to public motor vehicle travel, impact a stream or other water body through drainage, and meet program eligibility requirements.*

Funding Amount: *Funding varies by project and county allocation. The program receives an annual state appropriation of \$28 million, with at least \$8 million dedicated to low-volume paved roads. Grants are awarded through county conservation districts.*

Farm Vitality Grant

Sponsor/Agency: Pennsylvania Department of Agriculture

The Farm Vitality Planning Grant Program helps Pennsylvania farmers fund professional services that support long-term farm viability. The program is designed to strengthen farm businesses through business planning, ownership transitions, strategic expansion, diversification of agricultural production, financing planning, and the development of financial and technical advisory teams.

Eligible Recipients: *Pennsylvania farm owners and operators seeking professional planning assistance related to farm business management, succession planning, expansion, diversification, or other activities that support long-term farm vitality.*

Funding Amount: *Up to \$15,000, covering 75% of eligible project costs on a reimbursement basis. Applicants are responsible for the remaining 25% of project costs.*

Financial Assistance Programs for Organic

Sponsor/Agency: Pennsylvania Department of Agriculture

The Organic Certification Cost-Share Program (OCCSP) helps offset the cost of annual organic certification for certified organic operations in Pennsylvania. The program reimburses a portion of certification expenses to support producers and handlers maintaining USDA organic certification.

Eligible Recipients: *Certified organic operations, including those certified for crops, wild crops, livestock, and processing/handling activities.*

Funding Amount: *Reimbursement of 75% of eligible organic certification costs, up to \$750 per certification scope (crops, wild crops, livestock, and processing/handling).*

Highly Pathogenic Avian Influenza Recovery Reimbursement Grant

Sponsor/Agency: Pennsylvania Department of Agriculture

The Highly Pathogenic Avian Influenza (HPAI) Recovery Reimbursement Grant Program provides reimbursement to Pennsylvania farms, integrators, and allied poultry industries that experienced financial losses due to HPAI and were impacted by quarantine or control zones. The program also supports biosecurity improvements to help prevent future outbreaks and strengthen disease prevention measures across the poultry industry.

Eligible Recipients: *Pennsylvania farms, integrators, and allied poultry industry businesses that experienced financial losses from HPAI or are implementing eligible biosecurity improvements.*

Funding Amount: *Up to \$25,000 per premises for eligible biosecurity reimbursements; recovery reimbursement amounts vary based on documented losses and available funding.*

Next Generation Farmer Loan Program

Sponsor/Agency: Pennsylvania Department of Community and Economic Development (DCED)

The Next Generation Farmer Loan Program uses federal tax-exempt financing to provide reduced-interest loans for beginning and next-generation farmers. The program helps farmers finance capital purchases that support agricultural operations, including farmland acquisition, agricultural improvements, and equipment purchases.

Eligible Recipients: *Beginning and next-generation farmers seeking financing for eligible agricultural land, agricultural improvements, or depreciable agricultural property.*

Funding Amount: *Loans of up to \$682,000, with no more than \$62,500 used for the purchase of used equipment.*

Pennsylvania Agricultural Surplus System

Sponsor/Agency: Pennsylvania Department of Agriculture (administered through Feeding Pennsylvania)

The Pennsylvania Agricultural Surplus System (PASS) reimburses Pennsylvania farmers and food producers for costs associated with harvesting, processing, packaging, and transporting surplus agricultural products for donation to the charitable food system. The program helps reduce food waste, support local farms, and increase access to nutritious food for those experiencing food insecurity. PASS supports both surplus products and planned donations through contract planting arrangements.

Eligible Recipients: *Pennsylvania farmers and agricultural producers with eligible surplus food or agricultural products, including fruits, vegetables, eggs, dairy, poultry, pork, beef, grains, and value-added products made with Pennsylvania-sourced ingredients.*

Funding Amount: *Reimbursement for eligible costs associated with harvesting, processing, packaging, and transporting donated agricultural products. Funding amounts vary based on approved project costs and available program funding.*

Resource Enhancement & Protection (REAP) Program

Sponsor/Agency: Pennsylvania State Conservation Commission

The Resource Enhancement & Protection (REAP) Program provides Pennsylvania income tax credits to farmers, landowners, and businesses that implement conservation best management practices (BMPs) that improve water quality and reduce environmental impacts. The program helps offset the cost of conservation projects while encouraging the adoption of practices that reduce nitrogen, phosphorus, and sediment pollution.

Eligible Recipients: *Pennsylvania farmers, landowners, and businesses that are in compliance with Pennsylvania Clean Streams Law requirements and implement eligible conservation best management practices. Non-agricultural businesses and individuals may also participate by sponsoring eligible projects.*

Funding Amount: *Tax credits equal to 50%, 75%, or 90% of eligible project costs, depending on the conservation practice. Agricultural operations may receive up to \$250,000 in REAP tax credits within a seven-year period.*

Small Business Advantage Grant

Sponsor/Agency: Pennsylvania Department of Environmental Protection

The Small Business Advantage Grant Program provides reimbursement grants to Pennsylvania small businesses for projects that improve energy efficiency, reduce pollution or waste, upgrade equipment, improve operational processes, or reduce runoff into affected waterways. The program helps businesses lower operating costs while reducing their environmental impact.

Eligible Recipients: *Pennsylvania-based small businesses with 100 or fewer full-time employees that undertake eligible energy efficiency, pollution prevention, or natural resource protection projects.*

Funding Amount: *Reimbursement grants covering 50% to 80% of eligible project costs, with maximum awards ranging from \$7,500 to \$12,000 depending on the project's environmental impact and whether the business is located in an Environmental Justice Area.*

Urban Agriculture Infrastructure Grant

Sponsor/Agency: Pennsylvania Department of Agriculture

The Urban Agriculture Infrastructure Grant Program provides reimbursement grants to support individuals and organizations investing in urban agriculture infrastructure across Pennsylvania. The program aims to strengthen urban agriculture systems by addressing infrastructure gaps, encouraging collaboration, expanding operations, overcoming food deserts, and creating opportunities for social entrepreneurship. Grants are available as micro grants for one-time projects and collaboration grants for larger-scale efforts.

Very Small Meat and Poultry Processor Reimbursement Grant

Sponsor/Agency: Pennsylvania Department of Agriculture

The Very Small Meat and Poultry Processor Reimbursement Grant Program supports the growth of Pennsylvania's very small meat and poultry processing industry by reimbursing eligible expenses related to opening new processing operations, expanding existing facilities, and obtaining a USDA Food Safety Inspection Service (FSIS) Grant of Inspection. The program helps increase processing capacity, improve services for livestock and poultry producers, and expand access to Pennsylvania-produced meat and poultry products.

Eligible Recipients: *Very small meat and poultry processing operations in Pennsylvania that are currently operating under a USDA Grant of Inspection or will obtain a Grant of Inspection upon completion of the approved project.*

Funding Amount: *Up to \$100,000 per applicant*

Conservation Reserve Enhancement Program (CREP)

Sponsor/Agency: Vermont Agency of Agriculture, Food and Markets

Vermont's CREP is a voluntary program designed to reduce sediment runoff and improve water quality by removing land from agricultural production and establishing vegetative buffers. State and federal funds are used to compensate landowners for the loss of productive agricultural land through upfront incentive payments and annual rental payments based on the total acreage dedicated to vegetated filter strips, forested buffers or grassed waterways. Federal cost-share and incentive payments are available to cover 90% of the implementation costs associated with fencing, alternative water systems, stream crossings and vegetative buffer establishment. In most instances the costs may be 100% covered with help from the US Fish and Wildlife Service.

Eligible Recipients: Vermont Farms adjacent to a perennial stream or river that lack vegetative buffers and have agricultural related water quality impacts

Funding Amounts: 90% of the implementation costs

Diesel Emissions Reduction Assistance

Sponsor/Agency: Vermont Agency of Agriculture, Food and Markets

This grant helps to support farmers that are interested in switching over old diesel engines to a newer system or a different kind of engine. There are 2 routes that you can take each with funding limits. If you want to replace a diesel engine and switch to a new, zero tailpipe exhaust vehicle (grid, battery, or fuel cell), you are eligible for up to 45% of the costs to be covered. You can also install a newer cleaner diesel engine or a hybrid and get funded for up to 25% of the project.

Eligible Recipients: All farms and businesses located in Vermont

Engineering Services and Farmstead Best Management Practices Program

Sponsor/Agency: Vermont Agency of Agriculture, Food and Markets

The Agricultural Engineering Section assists farmers with on-farm improvements designed to abate non-point source agricultural waste discharges into the waters of the state of Vermont. The Section administers three programs to assist farmers: 1) The EQIP-Assist Program is an opportunity for farmers with NRCS EQIP contracts to receive additional cost share on the practices installed as part of the EQIP contract. 2) The Technical Assistance Program is available to provide water quality compliance consultations, state permitting assistance or variance assistance. 3) The Farmstead Best Management Practices (BMP) Program provides engineering services on a priority basis for the design of BMPs at no cost to the farmer and can cost share on the construction of eligible practices.

Grassed Waterway and Filter Strip (GWFS) Program

The Grassed Waterway and Filter Strip (GWFS) program provides technical and financial assistance to Vermont farmers for in-field agronomic best practices to address critical source areas, erosion and surface runoff. The program's goal is to reduce soil erosion and improve soil and water quality on cropland that contributes a disproportionately high level of nutrients in runoff. Such areas of cropland are considered "Critical Source Areas" (CSAs), representing a small proportion of the landscape yet a high proportion of nonpoint source pollution loads.

Eligible Recipients: *Vermont farm with an annual cropping history within 5 years and adjacent to surface waters and/or ditches*

Funding Amount: *90% of installation costs*
